Print size should be limited to a maximum of 10" x 8" **horizontal format**. Digital images must have sufficient resolution to produce quality print. Digital images should be a minimum of 300 dpi at 12" x 9" **horizontal format** to be considered for first place winning photos. An official entry form is required with each image you wish to submit. Pack your entries carefully.
